



# **Access to Justice Award 2024**

## Criteria and Terms for Award

#### **Purpose**

The Access to Justice Award is intended to recognise a New Zealander (or qualifying New Zealand resident) who has made an outstanding contribution to the promotion of access to justice (i.e., to improving fair and equal access to justice for individuals and/or communities).

This may have been through advocacy, leadership and/or influence.

It is anticipated that the winner of the Award will have demonstrated a strong commitment to access to justice and/or pro bono activities.

### Eligibility

- (a) The Award is open to all New Zealand barristers sole, barristers and solicitors, academics, and/or law students;
- (b) A Nominee must be nominated on or before the closing date for nominations in a given year. This year the Closing Date is 28 June 2024. The Nomination Form is available here. Once completed it should be sent by email to President@nzbar.org.nz.
- (c) A Nominee does not need to hold a current practising certificate;
- (d) A Nominee must be of good character;
- (e) The NZBA will undertake such due diligence as to the Nominee's good character as is considered to be appropriate;
- (f) A Nominee may not have previously been the recipient of the Award;
- (g) Self-nomination for the Award is permitted;
- (h) The Judging Panel members of the Award are ineligible;
- (i) Members of the NZBA Council are ineligible;
- (j) Teams, firms or groups are ineligible. The Award is open only to individuals; and
- (k) Should a nominated individual die before the Judging Panel makes their determination of the winner, the Judging Panel will consider that individual's nomination for the Award notwithstanding their death.

#### **Award Criteria**

The following criteria will be used by the NZBA Judging Panel to determine the winner (or winners) of the Award.

The weight that each member of the Judging Panel gives to these 3 criteria in their assessment of Nominees is entirely at their own discretion.

#### 1) Contribution

The extent to which a Nominee demonstrates significant contribution(s) to improving access to justice in the community and/or for individuals. This can encompass or be demonstrated by, for example:

- offering services pro-bono to individuals and/or community organisations;
- being a supplier of Legal Aid services;
- volunteering for community law centres and/or similar services;
- advocating for the access to justice needs of the vulnerable in the community;
- organising events or activities that promote or highlight access to justice issues;
- developing innovative service models to fill the access to justice gap;
- leadership to inspire, encourage and develop legal assistance and/or pro-bono services;
- making a career in the access to justice sector, for example, by working at a community law centre or for a charity;
- undertaking low bono matters; and/or
- fundraising for access to justice causes.

### 2) Impact

The extent to which a Nominee can demonstrate the impacts and outcomes of their contribution(s) to access to justice.

This may be demonstrated from an access to justice initiative driven by the Nominee or which the Nominee has supported.

It may also be demonstrated from a sustained record of service in the delivery of services to clients and/or the community.

#### 3) Leadership

The extent to which the Nominee has shown outstanding leadership, influence or innovation to enhance the provision, management and delivery of legal services to enable better access to justice outcomes for individuals and/or communities.

### **The Judging Panel**

Each year the NZBA Council will appoint a Judging Panel for the Award.

The Judging Panel will consist of 3 people.

This year the Judging Panel will consist of the following individuals:

- (a) A representative from the Sponsor;
- (b) The President of the New Zealand Bar Association or their nominee; and
- (c) A representative to be agreed jointly by the Sponsor and the NZBA.

The Judging Panel has the right:

- (a) not to make the Award in a given year; and
- (b) to give the Award to two individuals in a given year, in which case they will share the cash amount referred to below.

The Judging Panel's decision as to the winner (or winners) of the Award will be final and no correspondence will be entered into.

### Announcement of the Winner (or Winners) of the Award

The winner (or winners) of the Award will be publicly announced at the Gala Dinner at the NZBA's Annual Bar Conference (or similar event) by a representative of the sponsor, LexisNexis.

The NZBA and LexisNexis, the sponsor of the Award, may arrange for the winner (or winners) to be photographed, and use those images to publicise the Award in their own and third-party publications.

#### The Award

The winner (or winners) will be notified in advance and be provided one night's accommodation, transport to and from the conference location, and two tickets to the Gala Dinner.

The winner will receive a trophy.

The winner will also receive a tailored package (according to eligibility) from the sponsor of one of the following options:

- a. a complimentary one-year subscription to the NZBA e-library package, provided that the winner meets the eligibility criteria for that package.
- b. if the winner isn't eligible for the NZBA e-library package, customised online content package, valued up to \$3600.
- c. if the winner already has a subscription to the e-library, the sponsor will reimburse the amount of either additional content or a credit to the value up to \$3600 on the current account; or
- d. a donation of the equivalent amount to an organisation relating to the honouree's work or preference.

In addition, the winner will receive a cash prize from the NZBA of \$2000.
